APPROVED Treasurer's Report – Dave Bernardoni brought a motion to approve the Treasurer's Report and Financial Reports for the period ending 11/30/11, seconded by Roxan Hartstein. (Vote: 9-0). Motion passes.

- 5. RECEIVED Announcements and Reports - LAPD, Local, City, State and Federal Representatives A. LAPD – Senior Lead Officer (SLO) Dave Ham reports there were many arrests in the last month. More than 8 burglars from S. Central L.A. were arrested thanks to many tips from Neighborhood Watch folks who helped secure these arrests, as well as good work by the officers of Special Investigative Section (SIS) from LAPD. We hope they are kept in jail for their full sentence. During the holiday period, if you are expecting a package, communicate with you neighbors and have them check for it in your absence. Watch out for car theft at the mall Carry as little as you can. Don't leave valuables in sight. Sealing your house against the cold helps to keep out burglars, too. Steve Leffert mentioned he had seen pinted graffiti in tunnel under Sherman Way, where LBNC had cameras installed, which hasn't been cleaned up yet. Officer Paredes is in charge of it, but Officer Ham will see if he can get anything from cameras and check to see if cameras are working. Cal 311 and press pound key to bypass hello from Mayor, and report graffiti to West Valley Alliance directly at 818-885-8885. Use 311 for trash pickup and abandoned cars, that way citizens and city work as a team Question from stakeholders: Is the bike pathunder the freeway patrolled? Officer Ham patrols it daily. Drug users have died there who were selling. I's best to keep moving on the path. Attacks are rare. LAPD does sweeps of park for two reasons: to get rid of ex-cons and parolees and to give alerts about flooding. For safety, carry a whistle and pepper spray and have a plan. Neighborhood Watch newsletters have phone numbers for SLOs
 - B. Eric Richardson, Field Deputy CD12, Councilman Mitchell Englander's Office Motions in the works now are 1) Determining the full cost of OCCUPY LA at City Hall for future use and 2) City Budget: City Controller Wendy Greuel is working or performance based budgeting, checking the efficiency of each department. Work is being done on the 311 system to make it more user-friendly. Thursday, December 15 is "Day without a Bag." Various organizations will be handing out free re-usable bags to encourage bringing and re-using one's own bags to markets instead of using single use plastic bags, millions of which are larming ocean life right now. Steve Leffert said the City had good accountability, as he called in some illegal signs on Saticoy Street and they were removed the next day. He even received a follow-up call from Street Services. Question from stakeholders: What is Councilman's position on mobile billboards? Councilman hates them and a new law goes into effect Jan.1, 2012 that cleaned up the language and includes all types of vehicles. Call 818-756-8501 to report illegal mobile billboards parked on the street.
 - C. Linda Pruett –YEEHAW! The second bin has been filled! (First bin filled is at Woodley Lakes Golf Course parking lot.) The bin located at Stagg Street Elementary was filled in November in intermittent rain. Thanks to all who helped make this possible. Some very large kits were returned to SOS to be split in half. There will be a public viewing of the bins to let stakeholder know the contents and locations of bins. Emergency Preparedness Meetingon Dec.10, 9am at the Fly Away. - 8. Discussion/possible action regarding a conditional use permit to allow the sale of Firearms/ammunition, with said Business having hours of operation 9am– 7pm daily; in the M2 zone @ 7800 N. Business Center Parkway #103, 91406 (ZA 2011-2605 CU) Leffert "Gun Safari" is a duty gear store with retail firearms and ammunition sales by appointment only a business located north of Saticoy between Balboa and Hayvenhurst whch needs to secure a conditional use permit from City of LA Over nine stakeholders spoke in support; Steve Leffert confirms several Board Members have checked location; Linda Pruett notes that i's hard to find, a very safe facility, less prone to break-ins, and is 100% in support; Allen Nelson explains how they met all federal requirements and he fully supports; Dave Bernardoni states they must have a federally required safe bolted, over 30 security cameras, armed securty gate after 6pm, and they have a gate buzz-in system; Linda Schwering says hey have sales to ultimate endusers; Dave Bernardoni adds that it is located in Van Nuys, not Lake Balboa, however it is in boundaries for LBNC.

MOTION PASSED – Dave Bernardoni brought a motion to respond in order with "D" (Independent Election Administrator), "A" (Town Hall), "C" (DONE), "E" (Hybrid), and "B" last (Office of City Clerk) to Question #3, seconded by Matt Coles. Vote: (9-1). Motion passes.

MOTION PASSED – Dave Bernardoni brought a motion to respondwith "At Polls" to Question #4, seconded by Linda Pruett. Vote: (unanimous). Motion passes.

MOTION PASSED – Steve Leffert brought a motion to select "Mandatory Secret Ballot" to Question #5, seconded by Dave Bernardoni. Vote: (10-0). Motion passes.

12. Discussion/possible action regarding creation of an Ad-hoc Budget Committee – L. Schwering

MOTION PASSED – Dave Bernardoni brought a motion for the Lake Balboa Neighborhood Council to form an Ad-Hoc Committee to review remainder of 2011/2012 Budget with Linda Schwering as Chair. Vote: (8-0). Motion passes.

Volunteers include Ruth Doxsee, Cynthia Weichelt, Carl Schwering, Roxan Hartstein (as a maybe). Linda Schwering will contact group to meet in January for Board Reconciliation in February.

13. Discussion/possible action regarding letter of support of NC Donations Ordinarce – Weichelt Ordinance to allow monetary donations supporting renewingthe ordinance; to be added to next meeting's Agenda with more detail, email to Lynda Levitan Item Tabled – not enough information at this time

14. Discussion/possible action regarding watering truck cost for tree planting program – Nelson Roxan Hartstein recuses herself and leaves room to avoid conflict of interest, as she is in the building and design industry. Allen Nelson explains BOS offered Lake Balboa free street treesby adopting trees in front of homes and businesses, as urban trees counter air pollution; \$23.25 cost per tree per watering X 113 free trees planted by Urban Services Dept. beginning December 2011, as a cost effective way to enhance the area; 6 months cf watering service to keep them alive (approximately \$2,628 per watering) with watering not needed during months of rain; Lynda Levitan will look into alternative options

MOTION FAILS – Allen Nelson brought a motion for the Lake Balboa Neighborhood Cuncil to acquire 113 free trees, at \$2628 per watering of all 113 trees, seconded by Ruth Doxsee. Vote: (4-5). Motion fails. Coles, Bernardoni, L.Schwering, C. Schwering, Baird opposed, Weichelt abstained.

15. Discussion/ possible action regarding storage costs – L. Schwering MOTION: Expenditure of Funds: up to \$100 per month for rental of storage space to store neighborhood council materials and supplies.

MOTION PASSED – Linda Schwering brought a motion with regard to expenditure of funds, revise to \$105 per month for rental of storage space to store Neighborhood Council materials and supplies, seconded by Linda Pruett. Vote: (8-1). Motion passes.

16. Discussion and possible action approving expenditure of funds for meeting space rental– L. Schwering
