Neighborhood councils shall monitor the delivery of City services in their respective areas and have periodic meetings with responsible officials of City departments, subject to their reasonable availability.

9. Discussion and possible Action regarding State Assembly Bill 516 (AB516) will policies handcuff our Police Officers? - Possible Community Impact Statement (CIS) Brown –Everyone was handed the pack of papers with the Council File 19-0002-S50. The police have the power to impound and tow away vehicles that are breaking laws such as having more than 5 tickets, those that have not paid their registration in over 6 months, also cars that have been left more than 72 hours and ticketed or are abandoned on city streets. AB 516 will prohibit law enforcement from towing those vehicles. In May our City Councilwoman Nury Martinez presented a motion to create this Council File in opposition to AB516. This Bill was passed in the Assembly. It will be going before the Senate soon for a vote. Emma Thompson from Assemblymember Nazarian told the Lake Balboa Neighborhood Council that the Assemblymember voted to support the Bill. It passed overwhelmingly. The Bill was presented as a way to help the poor. However there was no opposition at that time. There is a lot more opposition now.

- 17. ANNOUNCEMENTS and REPORTS: Committee Chairs and Boardmembers-President Update: Civic University is worth the time if you can go. On the forms for our election the City Clerk asked for our birthdates which is a concern. Ms. Gravani asked the City Clerks' office what they would be doing with the forms after the elections. She was told that the forms will be given to the Neighborhood Councils. Due to the concerns raised by Ms. Gravani the birthdates will be redacted by the City Clerks office.
 - a. Emergency Preparedness Committee- Chair: Ms. Pruett. Meetings are held at the Van Nuys Fly Away- 7610 Woodley Ave. (Cross-street is Saticoy). Free parking is located in front of the Fly Away Building. Committee The meeting is this coming Saturday, 9:00AM. The meeting will be on Emergency Preparedness and Disaster Preparedness books. Please bring your favorite and we will pass them around. The Valley Disaster Fair will be on October 12, 2019 which is the second Saturday in October. Registration for the event will open on July 1, 2019. R.S.V.P. at valleydisasterfair.com. There will be no Emergency Preparedness Meeting scheduled during the month of July.
 - b. Health & Public Safety Committee- Chair: Mr. Brown. The Health and Public Safety Meetings are held at the Van Nuys Fly Away- 7610 Woodley Ave. (cross-street is Saticoy). Free parking is located in front of the Fly Away Building. Last meeting was May 18, 2019. The committee discussed fireworks, and being proactive about stopping, the illegal ones. The Next committee meeting has been scheduled for June 15, 2019. The next CPAB meeting will be on June 12, 2019 at 7:00 PM at West Valley Division. The topic will be Opioids, and will be presented by the National Council of Alcoholism and Drug Dependency of the San Fernando Valley. There are lawsuits that have been filed against drug companies. This is a National Epidemic.
 - c. Land Use Committee –Chair: Mr. Riley (thomas@lakebalboanc.org). The Land Use Committee Meetings are held the 3rd Monday of the month at 7:00PM at The Van Nuys Flyaway Bus Terminal 2nd Floor meeting room. There are many things that are going through planning in the Lake Balboa area. There are beer and wine licenses applied for at the 7-11 at Saticoy and Balboa and an application at the Ralphs at Balboa and Roscoe. In the industrial areas there have been four Storage Facilities approved this year. Now there is a fifth one being planned. When asked why so many are being built we are told that people need storage because they are renting out their garages for people to live in. Businesses also need to store files and equipment. One of the good things about storage businesses is they do not increase the communities traffic. There are about are 1-2 demolition applications a week for people putting additions on to their homes to rent out.

 - e. Sepulveda Basin Wildlife Areas Steering Committee (SBWASC) -Representative-Ruth Doxsee At the last meeting May 28, 2019 it was announced by a representative from Sheila Kuehls' office that the herbicide Glyphosate will no longer be used by the County. If you would like to give your opinion on the LA River master plan you can do it online at LARiver.com. There is a daily Topanga Beach Bus run by the County that goes to between Canoga Park and Santa Monica with 8 stops 1.00 each way to find out more information go to LAgobus.com to see the schedule and stops. The April 13, 2019 clean-up was a big success. There were 150 Volunteers that cleaned up tons of garbage. The next clean-up will be in September. There are over 500 Homeless people living in the Basin. Encino Neighborhood Council has also voted funding for the Clean Streets Clean Starts Program to perform work on the south side of Burbank Blvd. Homelessness is the biggest problem in the park. There are supposed to be 15 bridge housing projects open, but only 2 that have opened.

- f. Recreation & Parks -Chair: Mr. Stein (jimstein@lakebalboanc.org) Mr. Stein needs volunteer help to set up pop-ups and other Items for the Movie in the Park Event on June 15, 2019. The Movie is scheduled to start at 6:00PM. Volunteers should be there to set up at 5:30PM. Mr. Stein also gave an update on Measure A. Councilmember Nury Martinez wrote a letter of support for Lake Balboa to get money for park improvements. The Council File is CF 18-0611-S1 It has been determined that Lake Balboa has a great need for funds. The money will be used to fix the restrooms at Louise Park, improvements at Jesse Owens Park and the third project will be the open land next to Millies. \$582,000 Dollars will be given to each project.
- **g. Resilient Los Angeles-** Chair: Ms. Pruett: www.lamayor.org/resilience the plan is still being worked on. We do not know where the mandatory resilience plan is. There is no template yet
- h. LAPD Volunteer Police Representative: Ms. Pennomon There is a need for more new Volunteer Community Patrol officers. The requirements are that you need to serve twice a month. The Police Department needs us as their eyes and ears. Ms. Pennomon saw a huge fight between 20 to 30 homeless people that just suddenly stopped. There was garbage everywhere. She spoke about a big encampment by some abandoned buildings with mountains of trash. There have been cases of MRSA found in our West Valley Officers. Ms. Pennomon explained how drugs are being sold along the Orange Line.

Ms. Gravani read L.A. City Charter Sec. 909 Annual City Budget Priorities.

Each neighborhood council may present to the Mayor and Council an annual list of priorities for the City budget. The Mayor shall inform certified neighborhood councils of the deadline for submission so that the input may be considered in a timely fashion.

Speakers are scheduled to start at 8:30 AM The Event is very informative. You will learn about how city operates. You do need to R.S.V.P. so that you can be included in the Breakfast count and for free parking. After the General Session the participants break into regions for elections of their Budget Advocates if needed and a Regional Discussion.
