Laura's law was explained which was created to get help for those that are not getting follow up for mental health services. Laura Wilcox was killed by a man that was resistant to getting mental health care. The program that is available helps mental health resistant individuals to receive follow up care and oversight this is not a voluntary program. Violent acts, psychiatric hospitalizations, are reasons that someone would be referred to this program. It is not a program for homeless individuals who do not fit the criteria. Those are referred to the County Health programs. There are many steps to the program, several of them are set up to help the individual voluntarily enter into the program before it is court mandated after evaluation. Providers check on them once a week. The office is located in Little Tokyo area. There is a brochure on the back table.

10. Guest Speaker LAUSD Board Member Scott Schmerelson and School Police Chief Steven Zipperman. 20 min LBNC is requesting routine police patrol at trouble areas around Balboa & Haynes & the Orange Line.

LAUSD School Boardmember Scott Schmerleson introduced Robert Jackson his deputy. Mr. Schmerelson then introduced Chief Zipperman who is in charge of the Los Angeles Unified Police Department (LASPD) which has about 400 Sworn Officers and is the 5th largest Police Agency in the County of Los Angeles. The reason for the attendance is because of an ongoing problem at Balboa and Victory Blvds. Students are hanging out at that strip mall and in the alley. There are problems with tardiness, truancy and drug sales. This discussion was to bring all of the agencies to the table to discuss the issues, to reassure the community and ask for their help. Chief Zipperman introduced the LASPD officers that are patrolling the area and LAPD which is partnering to help address the issues. Some things are handled administratively, some by citation, and some by arrest. Several stakeholders asked questions and were answered by the officers. There are increased patrols which have resulted in several individuals being arrested for various crimes. One of the local apartment managers offered the LAPD and LASPD Officers access to all of the video camera footage. They need the community members that call in information to identify the suspects that the police catch. The Orange Line is also a problem for drug sales which is also being addressed. The School Police Dispatch Number is 213-625-6631.

Back door deals have already been made with the City Unions. The earlier the White Paper gets done the sooner the City Budget can be affected.

This program helps to get the homeless to clean-up areas that need to be cleaned such as street medians and the Sepulveda Basin. Other Neighborhood Councils have been giving money to this program. Don Larsen runs it. They have a Facebook Page. There are some pictures posted. The homeless generate lots of trash.

- b. Stacy Stakeholder- talked about photos she has seen, she feels it is a win-win program. She spoke with Mr. Larsen about the program and all of the Neighborhood Councils that are participating. He was at the meeting earlier but had to leave.
- c. Brian Allen- stated that it is the responsibility of the city to do these clean-ups, not the Neighborhood Councils job to pay for it. There were questions raised about where the cleanups would be done.
